White, glossy soft-PVC-foil with a polyacrylate-based, transparent adhesive coating on the backside

Thickness of the PVC-foil without the self-adhesive coating: 0.1 mm

Thickness of the self-adhesive foil: app. 0.11 mm

Mass per unit area of the self-adhesive foil: app. 149 g/m²
