1 Description of the building product

PVC-free digital print-films on basis of a surface-coated polypropylene in combination with a high transparent PVC-free laminating-film on basis of polypropylene with UV-protection each with a glossy surface and with an acrylate-based adhesive coating on one side; the film "ORAJET 3174G" is coated with a transparent adhesive, the film "ORAJET 3174XG" is coated with a grey adhesive

Thickness of the print-films without the self-adhesive coating: 0.1 mm Thickness of the laminating-film without the self-adhesive coating: 0.06 mm

Mass per unit area of the print-films: app. 140 g/m² Mass per unit area of the laminating-film: app. 77 g/m²

Colour of the laminating-film: colourless, clear
